

Alimony – Maintenance: what are you required to produce to court

THE COURT (POLICE IN CASE OF NON-PAYMENT) IN ASSESSING OF DUTY AND THE AMOUNT OF ALIMONY USUALLY REQUIRES THESE INFORMATION FROM THE PARENTS:

1. Nationality certificate of a minor
2. Confirmation of mother's/father's additional maintenance obligation to another minor child (especially the birth certificate of the minor child, a legally effective court decision on adjustment relations with the minor child)
3. The decision of the appropriate authority on providing social welfare mother/father and all persons living with the mother/father in the household (especially the decision of Labor Office about keeping records of job applicants, the decision of Czech Social Security Administration on the award of benefits and payment of welfare benefits, etc.)
4. Confirmation of mother's/father's a persons' living with mother/father in the household incomes for the years 2011 – 2015 – in the case of entrepreneurship the tax return for the years 2011 – 2015 (unless the tax return, the cash book)
5. The mother's/father's account statements stating the current final balance (passbooks, building savings, current accounts, savings accounts, pension additional insurance, term deposits, other accounts, accounts abroad)
6. Extracts from the Trade Register confirming mother's/father's and all persons' living with the mother/father in the household business
7. Extracts from the Commercial Register confirming the mother's/father's and all persons living with the mother/father in the household participation in business corporations
8. Extracts from the Land Register confirming the mother's/father's and all persons' living with the mother/father in the household ownership of immovable property in the Czech Republic, or other confirmation of their ownership of immovable property outside the Czech Republic
9. Documents confirming the mother's/father's ownership of securities (eg. shares, bonds), other property (eg. the collection of paintings, coins)
10. Documents confirming the the mother's/father's and all persons' living with the mother/father in the household ownership of motor vehicles
11. Mother's/father's declaration of her/his with housing associated costs, in the absence declaration or documentation especially of the amount of payment owner's contribution or rent.
12. In the case of minor's/mother's/father's health problems the medical reports concerning the minor's/mother's/ father's and state of health all persons' living with the mother/father in the household
13. Mother's/father's declaration of the costs associated with the minor's costs confirming ordinary and extraordinary costs of the minor (eg. school fees and tuition, meal allowance, after-school childcare, class fund, (public) transport costs, contracts for studies the minor, extraordinary costs associated with studies and personal development the minor, health care, medical equipment, interests, etc.), in the absence declaration or documentation confirming the amount of these payments

In respect of documents in foreign language it is necessary to present these documents with officially certified translation into Czech language.
